Our Services

Our mediations can be undertaken both in person at a location of your choice or by zoom. We have had a very positive experience with the utilisation of zoom mediations since Covid-19 and it is our preferred method of mediation in the future.

In our experience having the mediations occur by zoom reduces the stress and anxiety parties feel through participation in the mediation and legal process. Zoom mediations have particular value in maximising the prospects of resolution of all issues between the parties where there is significant conflict between the parties, where there is a power imbalance or where there are allegations of domestic and family violence.

Parenting

It is a legal requirement that separating couples attempt to resolve their dispute by way of family dispute resolution (mediation) prior to commencing court proceedings (some exceptions apply).

If a resolution is not able to be reached, a mediation certificate (section 60I) may be issued to enable the parties to commence court proceedings.

Property Settlement

Mediation is an invaluable method of resolving disputes between separating couples about the division of their assets, without the necessity of lengthy and drawn-out litigation.

The Family Law Courts recognise the importance of mediation by providing that parties must attempt mediation after the commencement of court proceedings, prior to a matter being listed for a Hearing date.
